WRITING INDICATOR DEFINITIONS

(MENTEE CORE)

Indicator Definitions Review

Written indicator definitions:

- Help to control the quality of services and program delivery
- Provide a reference for standardized reporting
- Create a common language for referring to the program and the number of people who complete the program

Indicator Definitions Review

Indicator Definitions should:

- Be written for each indicator on the M&E framework
- Outline how numbers are counted or calculated
- Account for all essential parameters [from Parameters workbook]
- Include all disaggregation variables [from M&E framework]

 Increase in number/percent of youth enrolled [Number of new youth enrolled since the program began]

 Number/Percent of program youth who exited the program having completed program requirements

- 3. Number/Percent of mentor-mentee relationships that meet minimum standards for evidence-based mentoring programs:
 - a. Number of relationships that meet minimum contact standards parameters for frequency, duration, consistency, and commitment.
 - Number of mentees for which individual growth plans were established to include short and long term goals
 - c. Number of mentees that achieved or made progress toward goals
 - d. Number of mentee youth reporting a "good" relationship with their mentor

4. Number/Percent of program youth that report being satisfied with the program

 Number/Percent of program youth who offend or reoffend (while enrolled/ 6 months after exit)

6. Number/percent of program youth who exhibit the desired behavior change in targeted behaviors (during reporting period/6 months after exit)

7. Number/Percent of program youth who exhibited an improvement in the perception of social support (while enrolled/6 months after exit)

- There are 7 Mentee Core Indicators that must be reported by each site.
- Each site should create indicator definitions for the first 5 Mentee Core Indicators.
- NCMI will create standard indicator definitions for the remaining 2 indicators which are behavioral outcomes that will be verified using the Outcomes Assessment Tool being developed by PIRE.

Definition: Tracking this indicator will demonstrate that the program emphasized incorporating best practices and evidence-based approaches for youth mentoring, specifically minimum contact standards, individual growth plans for youth and tracking progress toward goals, and determining youth perception of the mentoring match. This measure will assess model implementation adheres to selected proven strategies.

Data to calculate this indicator will be obtained from mentor-mentee attendance and activity logs, mentee individual growth plan, and the Mentee Match Survey. The attendance and activity log will be completed by the mentor at each match meeting and maintained in the match file. Attendance will also be entered into the client management database, and a query will be applied to determine if the contact standards have been met. Mentors will create mentee individual growth plans based on discussions with the mentee, and will record the observed degree of progress toward those goals quarterly. Mentees will complete the Mentee Match Survey at 2 months and 9 months after being matched. Their responses will be entered into a database to calculate the overall match score.

- Number of relationships that meet minimum contact standards parameters for frequency, duration, consistency, and commitment
 Mentees will be counted if the following can be demonstrated on their mentor-mentee match attendance records:
 - a. Weekly in-person contact (>45 weeks per year)
 - b. At least four hours of contact per month
 - c. Meeting times consistently coincide with scheduled times agreed upon by mentor and mentee
 - d. Mentor contacts mentee by telephone, email, or text at least once during the weeks when in-person meeting is not possible

Mentees will be counted if their mentor completed the Individual Growth Plan (IGP) outlining the mentee's goals AND the mentee has signed the IGP

3) Number of mentees that achieved or made progress toward goals

Mentees will be counted if their mentor indicates observes that the mentee has made progress toward stated goals. Mentors will revisit goals with mentees monthly as an opportunity to self-assess progress and set additional goals.
